# 1 | AGENTIVE

An Al-powered auditing platform used for planning, managing, and automating financial audits. It's also useful for requesting and testing audit evidence.

#### IN PRACTICE

Our audit professionals use Agentive in the following ways:

#### Test of Controls

For reviewing a company's Service Organization Controls (SOC) 1 Type II Reports and extracting key

information from these reports (e.g., auditor's opinion, comprehensive list of controls and controls objectives, summary of findings) using Agentive's Copilot feature.

#### Substantive Tests

For extracting and organizing relevant information, such as company name, statement period, account number, and ending cash balance, from the bank statements imported into Agentive. The organized information is then used for the primary working paper for seamless tie-outs or look-ups against the reported cash account balances.

# Review of Working Papers

For streamlining the process of reviewing working papers.

(Instead of manually reviewing working papers, auditors can simply review tie-outs within the Excel file exported from Agentive, verify the documentation of the Al-driven steps, and confirm the storage location of the original source documents.)



#### **SYSTEM INTEGRATION**

Agentive integrates with Excel, which makes it easier to export work papers, audit evidence, and sample documentation.

A data analytics and automation platform that can be used from the planning to the reporting stage of the audit process. It enables audit professionals to prepare, blend, analyze, and act on data even if they don't have extensive coding or programming skills.

#### IN PRACTICE

For stratification and random sampling (this involves the selection of actual samples and not the calculation of required samples).

#### Substantive Test of Details Procedures

For journal entry completeness testing, journal entry testing, etc.



#### **SYSTEM INTEGRATION**

Alteryx can be integrated with business intelligence tools like Tableau and Power BI.
